It is notified for general information that there will be a general election of members of the Council under **clause (a) & clause (b) of section 21 and clause (a) of section 3 of the Dentists Act, 1948 (Act XVI of 1948)** in accordance with the Rules framed by the Government of West Bengal under the said Act, vide Notification No.Medl.4818/2D-24/50 dated the 14<sup>th</sup> October, 1950 published in the Calcutta Gazette of the 26<sup>th</sup> October, 1950 and Dental Council (Election) Regulations, 1952 framed by Dental Council of India. **The Final Electoral Roll** for the election under clause (a) & clause (b) of section 21 and clause (a) of section 3 shall comprise of **Part 'A' and Part 'B'** of the Register of registered dentists corrected upto the **05<sup>th</sup> June, 2023**. Dentists whose names are borne in **Part 'A' or Part 'B'** of the above mentioned Register of this Council are hereby called upon to participate in the election under clause (a) or clause (b) of section 21 and/or clause (a) of section 3 of the Act.

All nomination of candidates shall be made in the prescribed form to be obtained from the Office of the Returning Officer by application in writing with payment of fees of **Rs.200/- (Rupees Two hundred only)**.

**The Election for both clause (a) & (b) of section 21 and clause (a) of section 3 will be according to the following programme:-**

**Last date for receiving Nomination Papers** by the Returning Officer in his office **upto 28<sup>th</sup> June, 2023 Wednesday, 3.00 p.m.**

Scrutiny of Nomination Papers for the election u/s 21(a) and (b) by the Returning officer in his office **on 04<sup>th</sup> July, 2023, Tuesday, 2.30 p.m.**

Scrutiny of Nomination Papers for the election u/s 3(a) by the Returning officer in his office **on 04<sup>th</sup> July, 2018, Tuesday, 3.30 p.m.**

Last date of withdrawal of Nomination Paper by notice in writing subscribed by the candidate and delivered to the office of the Returning Officer **within 07<sup>th</sup> July, 2023, Friday, 2.30 p.m.**

**If on the result of the scrutiny and of any withdrawal of candidature under Rule 6 and Rule 10 of the aforesaid Rules, there be more nominees than the vacancies, votes will be obtained by issue of voting papers by registered post under the following programmes:-**

Last date of despatch of Voting Papers **upto 10<sup>th</sup> November, 2023, Friday.**

**Date of Poll** (i.e. last date and hour for receiving Voting Papers by the Returning Officer in his office) for the Election u/s 21(a) & (b) either by hand or by post and for the Election u/s 3(a) by registered post **upto 30<sup>th</sup> November, 2023, Thursday, 3.00 p.m.**

**Scrutiny of Voting Papers and Counting of Votes** of the election u/s 21(a) & (b) to commence on and from **1<sup>st</sup> December 2023, Friday to 03<sup>rd</sup> December 2023, Sunday from 10.00 a.m. to 6.00 p.m. everyday and will continue till completion** by the Returning Officer in his office.

**Scrutiny of Voting Papers and Counting of Votes** of the election u/s 3(a) to commence on and from **04<sup>th</sup> December 2023, Monday to 06<sup>th</sup> December 2023, Wednesday from 10.00 a.m. to 6.00 p.m. everyday and will continue till completion** by the Returning Officer in his office.
