The **General Elections of this Council u/s 21(a) & (b) and u/s 3(a)** under the Dentists Act, 1948 will be held in May 2023 to December 2023.

The Preliminary Electoral Roll of the Registered Dentists (Part-A and Part-B), whose new registration/renewal of registration for the period upto 31st December 2023 was made within dated 16th May 2023, have been published and shall be kept open for public inspection in exercise of the Election Rules framed by the W.B. Govt. vide the Notification No.Medl.4818/2D-24/50 dt.14th October 1950 and Dental Council (Election) Regulations, 1952 framed by the Dental Council of India under the Dentists Act, 1948 (XVI of 1948) **in the office of the Returning Officer at Purta Bhavan, 3rd Floor, Room No.303, DF-Block, Salt Lake, Sector-I, Kolkata-700091 from 24th May, 2023 to 05th June, 2023.**

Any claim for inclusion of a new name of any objection to any entry in Preliminary Electoral Rolls, shall be made in the prescribed form in the Election Rules, namely "**PROFORMA FOR ELECTORAL ROLL**", as the case may be, (copies of which will be held on application from the office of the Returning Officer). Such claim or objection shall be filed within the said period namely from **24-05-2023 to 05-06-2023** for the section 21(a) & (b) and 3(a) and shall be examined and decided by the Returning Officer and his decision shall be final under the Election Rules of the Dentists Act, 1948 (XVI of 1948).

The Preliminary Electoral Roll shall be corrected **upto 05th June, 2023** in accordance with the decision of the Returning Officer and the Electoral Rolls thus corrected shall be the Final Electoral Roll for the election.

All the registered dentists (Part-A and Part-B) of this Council are hereby requested to apply in the aforesaid prescribed proforma for restoration of their names and for change of their permanent address, if any, so as to reach the office of the undersigned **on or before 05th June, 2023 at 3.00 p.m.** No objection relating to the entries or omissions in the said Electoral Roll shall be entertained **after 05th June 2023 at 3.00 p.m.** The Registered Dentists (Part-A and Part-B), whose name is not included in the Final Electoral Roll for the elections, shall not be entitled to participate in the elections.
